PRIVACY NOTICE

This privacy notice sets out how The Bugles & Drums of the Stedfast Association (BADOTSA LTD) the 'Band', protects and makes use of the information you give when you use our website or submit your details to us.

Any information provided to the Band will only be used in accordance with this privacy statement.

What information do we collect about you?

We collect information about you when you become a member or fill in any of our forms. Web site usage information is collected using cookies.

We may collect the following information:-

Name and date of birth

Home contact information (address, telephone and email)

Parental or guardian information (if data subject is under 18)

Emergency contact information

Information about illness or disability relevant to your involvement with the Band

Personal image through photography and video

Website usage data

How will we use the information about you?

Collecting this data helps us communicate with you regarding band events, functions and property. Specifically, we may use data:-

To provide you with information on our events and rehearsals

To administer events (such as publicity or attendance)

To contact you

Basis for processing under GDPR

We process personal data obtained prior to 25th May 2018 under the Legitimate Interest basis for establishing and continuing relationships with new and existing contacts. For data obtained after 25th May 2018 we process personal information using consent as our basis for processing.

How long will we keep your information?

We remove personal information where there has been no active interaction during the last two years (active interaction being attendance at an event, requesting information, or clicking on newsletter articles).

Your right to access, rectify and remove data

You have qualified rights to access, rectify and erase your personal data and to restrict or object to processing and to make your data portable. You have the right to complain to a supervisory authority (e.g. the Information Commissioner's Office).

Marketing

We would like to send you information about events and services of ours which may be of interest to you. You have a right at any time to stop us from contacting you for marketing purposes. If you no longer wish to be contacted for marketing purposes, please email info@badotsa.co.uk

Cookies

Cookies are text files placed on your computer to collect standard internet log information and visitor behaviour information. This information is used to track visitor use of the website and to compile statistical reports on website activity.
